a minor, child and/or dependent (hereinafter referred to as the “minor guest”). I certify based on my personal knowledge, the minor guest is a safe hunter or fisher.

As a condition of and in consideration of allowing the minor guest to hunt, fish or use Amwell Valley Conservancy, Inc. (AVC), property, I promise that I will accept full responsibility for my conduct and that of the minor guest. I certify and agree, individually and on behalf of the minor guest (collectively referred to as “I”), at all times when hunting or fishing on AVC property, or otherwise using the property for AVC functions (also collectively referred to as “use” or “using” AVC property) to the following: I shall act in a safe manner; I shall possess a valid New Jersey hunting/fishing license; I shall be in lawful possession of any firearms; I understand that hunting and fishing are hazardous activities and can involve risk of injury or death especially if safety rules are not obeyed; I have received and read the set of AVC safety rules prior to hunting and fishing and fully understand all safety obligations, including, but not limited to, that hunters must wear a cap made of daylight fluorescent orange material and an outer garment containing at least 200 square inches of daylight fluorescent orange material visible from all sides at all times while hunting; I understand that I could contract an illness while on AVC property such as, but not limited to, Avian (bird) flu, Lyme disease, and Babesiosis; I understand that AVC does not guarantee my safety or freedom from injury or disease while hunting, fishing or using AVC property; I agree that I will and hereby indemnify and save harmless AVC, its Directors and Employees from and against any and all actions, claims, demands, losses, damages, illnesses, costs or expenses whatsoever, including but not limited to reasonable attorney’s fees and defense costs, that may result from my use of AVC property; I further agree that I will and hereby release AVC, its Directors and Employees, from any and all responsibility or liability for death, injuries, illnesses, or damages that I might receive or sustain from my use of AVC property.

To reiterate the above, I understand that hunting and fishing are hazardous activities and can involve risk of injury or death especially if safety rules are not obeyed. I understand that AVC does not guarantee the minor guest’s safety or freedom from injury, death, illness or damages while hunting, fishing or using AVC property. I agree that the minor guest shall be bound to all the terms hereof in the same manner as I am.

I certify and agree that I have fully explained and discussed the terms hereof with the minor guest, who has acknowledged to me that he or she fully understands them, agrees to abide by them and shall at all times act as a safe hunter or fisher. I have caused the minor guest to execute this form below to acknowledge this. The minor guest has my permission, subject to the terms hereof, without reservation, to hunt, fish or utilize AVC property.
