

AVC DEER HUNTING AND TREESTAND SAFETY
REQUIREMENTS AGREEMENT

I understand that deer hunting and any activities associated with same including but not limited to the use of any TREESTAND at AVC property is a hazardous activity and can involve risk of injury or death especially if safety practices are not observed. I understand that Amwell Valley Conservancy, Inc. ("AVC") does not guarantee my safety or freedom from injury or death while deer hunting or engaging in any activities related to same at AVC property, including but not limited to my use of any TREESTAND at AVC property.

While deer hunting or engaging in any activities related to same and/or at any time that I use a TREESTAND at AVC property, I agree that I shall AT ALL TIMES utilize a proper TREESTAND SAFETY ROPE LINE and proper TREESTAND SAFETY HARNESS and a proper TREESTAND SAFETY HARNESS TREE ATTACHMENT, which includes when climbing up into, sitting in, and climbing down from any treestand. If I use an AVC TREESTAND, a treestand safety rope line and treestand safety harness tree attachment will be provided by AVC and I agree that it is my obligation, at my sole cost and expense, to acquire and utilize a proper treestand safety harness that is designed, intended and fit to be used for this purpose. If I use MY OWN TREESTAND, I agree that it is my obligation, at my sole cost and expense, to acquire, install and utilize a proper treestand safety rope line, proper treestand safety harness and proper treestand safety harness tree attachment that are designed, intended and fit to be used for this purpose.

I agree that I will indemnify and save harmless Amwell Valley Conservancy, Inc., its Directors, Employees and Members against any and all actions, claims, demands, losses, damages, costs or expenses whatsoever that may result from deer hunting or engaging in any activities related to same and/or at any time that I use a TREESTAND at AVC property. I further agree that I will release Amwell Valley Conservancy, Inc., its Directors, Employees and Members, from any and all responsibility or liability for any injuries, my death or damages that I might receive regarding same.

I agree that the provisions of this agreement shall supplement but in no way supersede or modify any other release and indemnification agreements that I have executed as a Member of AVC, and shall in no way modify or supersede any of the hunting and safety rules and regulations promulgated by AVC, as set forth in the Annual Membership Handbook or otherwise and to which I am bound as a Member of AVC.

I AGREE THAT THE PROVISIONS OF THIS AGREEMENT SHALL APPLY REGARDLESS OF WHETHER I USE AN AVC TREESTAND OR MY OWN TREESTAND.

I HAVE CAREFULLY READ THIS AGREEMENT, TOGETHER WITH THE SAVE HARMLESS, INDEMNITY AND RELEASE PROVISIONS AND FULLY UNDERSTAND THE CONTENTS. I AM AWARE THIS IS A CONTRACT BETWEEN ME AND AMWELL VALLEY CONSERVANCY, INC. AND INTEND TO BE FULLY BOUND BY IT.
